b. DOCUMENT & CONSIGNMENT DEADLINES

1. SEAFREIGHT

In accordance with the Vietnam rules for the importation of exhibition goods, the Ministry of Trade MUST grant a PRE-ENTRY approval prior to entry.

To comply with this ruling and for customs conversion purpose, all exhibitors are required to submit to us copies of the Commercial Invoice/Packing List not later than **20 NOV 2022**. For machines and technical equipment, please send us a copy of their catalogues for our easy custom declarations.

Special license are required for temporary import of telecommunication, medical equipment, chemical, pharmaceutical & cosmetic products and food stuff. A fax copy of detailed Commercial Invoice & Packing List, Catalogue of Exhibit and appropriate support documents are to reach us at least 25 days prior to arrival of cargo.

For customs clearance purpose, the following documents must REACH us by 20 NOV 2022.

2. AIRFREIGHT

In accordance with the Vietnam rules for the importation of exhibition goods, the Ministry of Trade MUST grant a PRE-ENTRY approval prior to entry.

To comply with this ruling and for customs conversion purpose, all exhibitors are required to submit to us copies of the Commercial Invoice/Packing List not later than **25 OCT 2022**. For machines and technical equipment, please send us a copy of their catalogues for our easy custom declarations.

SOLAS/VGM Weighing and Processing Fee

Effective 1ST July 2016, International Maritime Organization (IMO) has made amendments to the Safety of Life at Sea (SOLAS) convention. SOLAS will require mandatory verification on the **gross weight** ("VGM") of all packages/pallets/containers etc.

Agility will be arranging to weigh all FCL and LCL cargo to attain the VGM. Additional cost hereunder applies:-

OTHER SHIPPING CHARGES

a. COURIER OF FILMS, VIDEO TAPES, DISCS AND/OR BROCHURES

Any films and video tapes/CDs/VCDs, brochures, catalogues to be shown at the exhibition must be cleared by the **Cultural and Information Department** in Hanoi. We would advise you against hand-carrying these items into Vietnam, courier consign to your hotel or the venue as they may be detained by Vietnamese Customs and considerable time and effort may be required to clear them out in time for the exhibition. All shipment sent via Courier Services must be customs cleared under Permanent Importation.

Should courier shipments to be imported on temporary basis, the handling charges for normal air shipment will be applied accordingly.

From arrival at Agility's premises in Hanoi up to delivery to exhibition stand, excluding the censorship fee levied by the **Cinematography Department**, the following handling charges will apply.

US\$60.00 per consignment up to 60 kg
US\$80.00 per consignment up to 80 kg

b. CENSORSHIP IMPORTATION

Brochures, catalogues, films and video tapes/CDs / VCDs / DVDs to be used at the exhibition are subject to Censorship Import License by the **Cinematography Department** in Vietnam.

You are advised to courier these materials "Freight Prepaid" to us by 26 OCT 2022 to enable us to arrange for censorship clearance

In case should any films & video tapes/discs included in airfreight/seafreight, the above application handling charge for censorship import license will be applied accordingly. These shipments must arrive **five (5)** working days earlier than cargo arrival deadline.

Should films & video tapes/discs arrive via airfreight/seafreight, the tariffs for airfreight/seafreight shall apply. A censorship fee will also be imposed by the customs and this shall be charged to the exhibitor as per outlay.

c. CUSTOMS CONVERSION FOR GIVE AWAY / CONSUMED CARGO

All give away / consumed cargo must be declared as permanent import items in the CCIPL as the Vietnam Customs will require the exhibitors to pay for the duties and taxes before releasing the cargo.

Should the giveaway/consumed cargoes are shipped together with temporary importation items, Agility strongly suggest to be packed into different packages from the temporary importation items so that Agility can do custom clearance separately. In this case, additional charges for custom clearance for giveaway / consumed cargo will occur as follow:

Brochures and giveaway items are permitted entry into Vietnam but subject to import duties of between 20% and 30% based on the Declared/Market Value whichever is greater and a 10% VAT based on the value assessed by the customs.

Once the show ends, if declared permanent importation cargoes need to be re-exported, this shipment will be exported as normal cargo from Vietnam and the additional customs clearance fee and outward handling charges will be applied.

d. HEAVYLIFT HANDLING FEES

Individual exhibit in excess of 3,000 kgs per package or the dimension of each packages not excess $3m(L) \times 2m(W) \times 2m(H)$ will incur heavy-lift surcharge (in addition to the basic handling charge).

e. CRANAGE

CUSTOMS REGULATIONS

The Vietnamese Authorities allow exhibits to be imported under 'temporary import' basis but exhibits must be re-exported within one month from the close of the show.

We do not recommend that the exhibitor ship foodstuff or beverages to the exhibition and would suggest the exhibitor buy them in Vietnam. If it is essential that the exhibitor bring their own, please ensure they are packed and documented separately from the exhibits to avoid delays in the customs clearance. It should also be sent on a separate Bill of Lading or Airway Bill.

Please be guided that imported foodstuff and beverages attract very high duty rates (between 70% and 150%). No exemption will be granted.

Temporary importation of some specific products such as telecommunication, medical equipment, chemical, pharmaceutical, cosmetic products, food stuff and beverage, plants is subject to special import license granted by relevant Ministries. Fax copy of detailed Commercial Invoice & Packing List, Catalogue of Exhibit and appropriate support documents are to reach us at least 25 days prior to arrival of cargo.

ATA CARNET

The ATA Carnet is not an acceptable document in Vietnam.

RE-EXPORT

Re-export formality will require about 3 weeks prior to the shipment to be re-exported out of Vietnam. In the event, the exhibitor needs the goods to be re-exported urgently, please notify our representative on-site.

TEMPORARY IMPORTATION

Cargo that is imported into Vietnam under 'Temporary Importation' is solely meant for exhibitor purposes and must be re-exported out of Vietnam within 30 days from the closing date of the exhibition. There is no extension permit granted by the Customs. Should the shipper require keeping their shipment in Vietnam for more than 30 days after the show closes, Agility can transfer the shipment to customs bonded warehouse on behalf of the shipper and all relevant charges will be billed to the exhibitor's account.



CONVERSION OF TEMPORARY-IMPORT TO PERMANENT-IMPORT STATUS

All exhibits that are brought in under Temporary Import can be sold at the exhibition. However, all relevant duties/taxes/vat must be paid at the end of the exhibition.

The buyer/local agent is responsible for the application of the import license from the Ministry of Trade. If conversion service is require, Agility will be able to facilitate in the conversion from temporary import into permanent import under Commercial trade term with full documentation and license provided by buyer and seller.

AT THE CLOSE OF THE EVENT

It is imperative that every exhibitor has completed and signed the Return Shipping Instruction Form before they leave the exhibition. Agility will not be held responsible for any sort of loss or damage incurred due to an exhibitor not completing or signing the form correctly. If the exhibitor needs to change the number of packages returning and has failed to provide Agility with the revised instruction. Agility will not be held responsible for any such discrepancies in the piece count.

If for some reasons the exhibitor has not been able to meet with our representatives, and the exhibitor have a return shipment requirement, they should either visit our site office or contact our Agility representative at the earliest opportunity to complete their disposal instructions.

If the exhibitor has sold their exhibits to a 3rd party during the event, it is sole responsibility of the exhibitor thereafter and Agility will not accept responsibility for any loss or damage after this time unless otherwise specified in writing. The exhibitor must be present to oversee the collection of all Exhibits.

VAT ON SERVICES RENDERED

All services rendered will be subject to 8% VAT as per Government's regulation.



INSURANCE

We would like to advise that it is the responsibility of each exhibitor to arrange Marine (Transport) Insurance covering transport to the exhibition, during the exhibition, and the return of the exhibits to domicile, including the period the exhibits are handled by Agility Fairs & Events Logistics Pte Ltd, and also ensure that Transport Insurance in arranged for exhibits sold locally.

Our tariff is computed on the basis of volume and weight and has no correlation with the value of exhibits, it follows that the cost of insurance cover is not included in our charges.
